Completed Carbon Reduction Initiatives

Topp Language Solutions has proactively adopted multiple sustainability measures to minimise our carbon footprint:

- Energy Efficiency Enhancements: Our office operates on low-energy LED lighting with motion-sensing capabilities to optimise electricity usage.
- **Remote Service Delivery:** Over **85% of meetings and consultations** are now conducted virtually, significantly reducing business travel emissions.



- **Eco-friendly Procurement:** We prioritise working with suppliers that adhere to sustainable practices and actively review our procurement policies.
- Waste Reduction and Digitalisation: Implementation of a paperless policy, reducing reliance on printed materials and single-use plastics.

Future Carbon Reduction Initiatives

To further reduce emissions, we will implement the following initiatives:

- **100% Renewable Electricity by 2026:** Transitioning all office electricity sourcing to renewable energy providers.
- Carbon Reduction in Business Travel: Reducing travel-based emissions by 20% by 2027, promoting remote-first engagements and sustainable transport options.
- Employee Commuting Improvements: Encouraging and incentivising carpooling, cycling, and hybrid work models to reduce employee commuting emissions by 30% by 2030.
- Supplier Engagement: Ensuring that all new supplier contracts include sustainability criteria and measurable carbon reduction commitments.
- Technology & IT Efficiency: Implementing low-energy servers and cloud computing solutions that minimise power consumption.
- **Investment in Verified Offsets by 2030:** Offsetting unavoidable emissions through **high-quality carbon sequestration projects** aligned with best practices.

Carbon Reduction Targets

Topp Language Solutions will track and report emissions annually, working towards the following reduction milestones:

- **10% reduction in business travel emissions by 2027** through continued remote-first policies.
- **30% reduction in Scope 2 electricity emissions by 2030** via energy efficiency improvements and renewable sourcing.
- **50% total emissions reduction by 2035** through comprehensive action across all scopes.
- Achieve full Net Zero by 2040, ahead of government targets.

Governance and Review



To ensure continued progress, Topp Language Solutions will **formally review its carbon reduction plan Annually**, adjusting strategies as needed based on real-world impact assessments.

Senior Management will oversee all emissions tracking and reduction initiatives for quick strategic decision-making purposes.
